These terms and conditions govern the Day-Old Layer Chicks Promotion offered by Hens Paradise PTY LTD and are applicable to all qualifying orders placed on **Thursday, 3 July 2025, between 09H00 and 14H00** via our official website: [www.hensparadise.co.za/#form](http://www.hensparadise.co.za/#form)

## 1. Promotion Details

Receive the promotional price of R1795.00 per box of day-old layer chicks (excluding delivery, IRBT, etc costs) on every second box ordered by the same client, provided the order meets the eligibility criteria below.

The first box is billed at the standard price of R2500.00, (excluding delivery, IRBT, etc costs).

The promotion applies only to orders of Lohmann Brown or Hy-Line Brown A-grade, vaccinated, sexed day-old chicks (100 chicks per box).

## 2. Promotion Eligibility Criteria

To qualify for the promotional pricing:

Clients must order a minimum of 2 boxes.

Both boxes must be:

- Of the same breed
- Delivered to the same address
- Delivered on the same date

Offer valid for South African residents only, with delivery within South African borders.

#### **4. Payment Terms**

Full payment required on the same day (**Thursday, 3 July 2025**) between **09H00 and 15H00**. Client to use name, surname, and invoice number as payment reference (e.g., Susan Smit – 1125).

No delayed EFTs, pay-later options, or part payments will be accepted.

Cash payments attract a 10% surcharge to cover banking fees. Client to add 10% of invoice amount for cash deposit into Hens Paradise account.

Road Transport to the nearest designated delivery point to ensure prompt delivery to all clients on delivery date.

Airfreight to selected airports (client to collect from cargo section).

Third-party delivery / collection must be arranged by the client.

Delivery costs and IRBT (beak trimming) are excluded from promotional pricing and are for the client's account.

#### **6. Availability & Limitations**

Promotion is limited to 50 selected boxes only.

Operates on a "First Come, First Served" basis.

Clients may secure orders for future delivery dates up to Friday, 29 August 2025 (Week 35).

Orders cannot be split and must be delivered to one address at one time, as per invoice.
